

CONSENT FOR A MINOR CHILD TO VISIT LAKE O' THE WOODS CLUB, INC.

A NUDIST ORGANIZATION LOCATED AT VALPARAISO, INDIANA

- That Lake O' the Woods Club ("LOWC", the "Club") is organized for members and guests to enjoy nude recreational activities, including swimming, boating, hiking, volleyball, and other athletic activities, sunbathing, group meals, and social gatherings while nude.
- That the minor child will be in the presence of unclothed male and female persons of all ages while visiting LOWC, and that the minor child may participate in nudist recreational activities as allowed by Club rules.
- That LOWC's rules for visitors apply to the conduct of both the child and the accompanying adult named above, and acknowledge receipt of a copy of these rules.
- That LOWC has been in operation since 1933, is incorporated in the state of Indiana, and is affiliated with the American Association for Nude Recreation.

I/we, the parent(s)/legal guardians of the above named minor child, hereby agree to hold harmless and indemnify Lake O' the Woods Club, its Officers, Board of Directors, members, employees, and/or agents for any and all expenses, damages, charges, and costs to include attorney fees which those entities, officers, or persons might have to pay by virtue of permitting the above named minor child to visit and come upon the Club property located at Valparaiso, Indiana, from damages to anyone from intentional or negligent acts of the adult designee, any Club member, and/or Club member's family and any other person upon the property with or without permission of the Club.
